

**ORDINANCE NO. 1031  
BOROUGH OF HATBORO  
MONTGOMERY COUNTY, PENNSYLVANIA**

**AN ORDINANCE AMENDING PART 4, SECTION 15-402, OF THE  
HATBORO BOROUGH CODE OF ORDINANCES, ENTITLED  
"PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS",  
TO ADD PARKING RESTRICTIONS ON CERTAIN STREETS**

**WHEREAS**, the Borough Code, 53 P.S. § 45101, et seq., authorizes the Borough Council of the Borough of Hatboro ("Borough Council") to make and adopt ordinances that are consistent with the constitution and laws of the Commonwealth when necessary for the proper management, care and control of the Borough and the maintenance of peace, good government, health and welfare of the Borough and its citizens;

**WHEREAS**, the Borough Council deems it be in the best interest and general welfare of the citizens and residents of the Borough to amend its Code of Ordinances, Part 4, Section 15-402, entitled "Parking Prohibited at All Times In Certain Locations" to add certain streets to the list where parking shall be prohibited at all times.

**WHEREAS**, the Borough Council, after due consideration of the proposed ordinance at a duly advertised public hearing, has determined that the health, safety, and general welfare of the residents of Hatboro Borough will be served by the amendment of the Hatboro Borough Code of Ordinances.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by the Borough Council of the Borough of Hatboro, Montgomery County, Pennsylvania, and it is hereby enacted and ordained by the authority of same as follows:

**SECTION 1. CODE AMENDMENT.**

**PART 4, SECTION 15-402, OF THE HATBORO BOROUGH CODE OF ORDINANCES, ENTITLED "PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS" IS HEREBY AMENDED TO ADD THE FOLLOWING:**

**§ 15-402. Parking Prohibited at All Times In Certain Locations.**

Parking shall be prohibited at all times in the following locations:

<b>Street</b>	<b>Side</b>	<b>Between</b>
West Lehman Avenue	North	From South York Road, 200 ft. West on Lehman Avenue
West Lehman Avenue	North	West Lehman Avenue from Bank Street to a point 40 ft. East on West Lehman Avenue

Horsham Road	North	From South York Road, West to Academy Road
Horsham Road	Both Sides	Between Academy Road and the Borough boundary with Upper Moreland Township
Windsor Avenue	East	From Summit Avenue to a point 110 ft. North
Montgomery Avenue, West	South	From Abbots Lane to North York Road

**PART 4, SECTION 15-402, OF THE HATBORO BOROUGH CODE OF ORDINANCES, ENTITLED "PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS" IS HEREBY AMENDED TO DELETE THE FOLLOWING:**

<b>Street</b>	<b>Side</b>	<b>Between</b>
Montgomery Avenue, West	North	From Abbots Lane to North York Road

**SECTION 2. REPEALER.**

All Ordinances or parts of Ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed.

**SECTION 3. REVISIONS.**

The Council of the Borough of Hatboro does hereby reserve the right, from time to time, to adopt modifications of, supplements to, or amendments of its Ordinance, including this provision.

**SECTION 4. SEVERABILITY.**

In the event that any section, sentence, clause, phrase or word of this Ordinance shall be declared illegal, invalid or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent, preclude or otherwise foreclose enforcement of any of the remaining portions of this Ordinance.

**SECTION 5. EFFECTIVE DATE.**

This Ordinance shall take effect immediately and be in force from and after its enactment as provided by law.

**SECTION 6. FAILURE TO ENFORCE NOT A WAIVER.**

The failure of the Borough of Hatboro to enforce any provision of this Ordinance shall not constitute a waiver by the Borough of its rights of future enforcement hereunder.

**SECTION 7. ENACTMENT.**

Under the authority conferred by the Borough Code, 53 P.S. § 45101, et seq., and other relevant statutory law, the Council of the Borough of Hatboro in the County of Montgomery, Commonwealth of Pennsylvania does hereby ordain and this Ordinance for the Borough of Hatboro, this 28<sup>th</sup> day of MARCH, 2016.
